Parking spaces are reserved for the purchaser only. Payment by a student's parent is a qualified purchase of a permit.

Sharing of parking spaces must be approved by the church office. All vehicles to be parked on the lot must be registered in the church office.

If you have a need to use a vehicle that is not registered, please contact the church office before leaving the vehicle on the lot. Put your permit on top of the dash behind the steering wheel so it can be easily seen thru the windshield. Temporary parking permits are available in the office.

Replacement permits are also available in the church office.

If you find someone parked in your space please report it to the church office. Let us handle any confrontations with the person who is in your space. You also should not take someone else's space. Instead please leave your vehicle in a visitor's spot or a handicapped spot.

Please pull all the way forward in your parking space to keep the lanes open for traffic to move freely.

The parking lot speed limit is 15 mph. The entrance to and the exit from the lot are clearly marked and should be used accordingly.

I understand that special church events will take precedence over my parking permit particularly scheduled funerals. Any funerals will be announced as soon as possible and your cooperation for arranging alternate parking during funeral services is greatly appreciated.

I agree not to hold College Place United Methodist Church liable or responsible for any loss or damage which may occur to my vehicle while it is parked in the lot.

Violations of any portion of this agreement will result in immediate surrender of the parking space and forfeiture of your rental fee. No refunds will be given.
